



General Rental Conditions:

The customer confirms that they have received the rented products in good condition and commits to returning them in the same condition. In case of damage, loss, or misuse, the customer will be responsible for compensating Son Vida Golf S.L.U. and accepts that such compensation may be charged to their credit card or room.

BUGGY RENTAL SPECIFICATIONS:

1. **Usage Instructions:** The customer agrees to read and understand the usage instructions before driving the buggy. In case of any doubts, they should ask the caddy master for clarification.
2. **Permitted Areas:** The buggy should only be driven in designated areas (asphalt paths or, if not available, on the edges of the fairway or rough). The customer must respect the golf course staff's instructions.
3. **Driving Conditions:**
 - Only the designated driver may operate the buggy.
 - The buggy must be used with a maximum of two occupants, both seated with their bodies inside the vehicle during movement.
 - The customer must drive carefully around curves, on slopes, and hills, engaging the parking brake when stopping and turning off the buggy when not in use.
4. **Prohibitions:**
 - Driving under the influence of alcohol or drugs is strictly prohibited.
 - Minors under 18 years old are not authorized to drive.
 - The buggy must not be driven outside the designated areas.
5. **Responsibility:** The customer assumes responsibility for any damage caused to the buggy, other vehicles, or facilities due to negligent or reckless driving.
6. **Liability Waiver:** The customer waives any claims against Son Vida Golf S.L.U. for personal or property damage, whether due to negligence or any other cause, arising from the use of the buggy.

Buggy Rental Declaration and Confirmation:

The undersigned, when renting a buggy, **DECLARES AND CONFIRMS** the following:

1. That as part of the package contracted with Son Vida Golf S.L.U., they are offered the possibility of renting an electric vehicle (buggy) for use during the effective playing time on the golf course.
2. That they have carefully read the instructions for the use of the electric vehicle, understood its content, and agree to comply with all applicable traffic and safety rules, especially those related to the prohibition of driving under the influence of alcohol or drugs.
3. That they understand and assume, under their own responsibility, the inherent risks of driving the electric vehicle, both for their physical integrity and that of others.
4. That they agree to be liable for any damage caused to the rented electric vehicle, other vehicles, or golf course facilities due to reckless or negligent driving, as well as for any failure to comply with the established regulations.
5. That they expressly waive, on their own behalf and on behalf of any third party acting on their behalf, any claims against Son Vida Golf S.L.U., its employees, affiliates, or any legal entity directly or indirectly related, for any bodily harm (including death), loss, theft of personal belongings, or other material damage of any kind, which may occur as a result of the use of the electric vehicle, whether due to negligence or any other cause, known or unknown.
6. That they agree to comply with all responsible driving rules, avoiding dangerous maneuvers and always driving with caution to ensure both their own safety and that of other users.
7. That they will respect all signage and routes indicated by the golf course staff. It is strictly prohibited to drive the buggy in unauthorized or non-designated areas.
